In order to join a cruise ship, the Cruise Line requires you to hold the following documents:

- American Club Pre-Employment Medical Examination
- The original certificate of Blood Test (Serology V.D.R.L).
- The original Blood Test for Hepatitis.
- The original certificate of Urinalysis (for sugar and proteins).
- The original of chest X-ray.
- The original vaccination certificate for Yellow Fever and Tetanus.
- Valid Safety certificate **IMO STCW-2010** with **Basic Training and Crowd management**.
- Valid **IMO STCW-2010 A-VI/1-6 (Proficiency in Security Awareness)**.
- Valid Passport with at least 6 months expiration date.
- Seaman's book (where required).

ADDITIONAL INFORMATION

The medical form should be filled out by the medical center (with signature and stamp) 20 day before your embarkation on the Vessel.

The medical form must be renewed annually or every 2 years
(Depending on the cruise line regulations)

All the medical examination (except x-ray) must be renewed annually or every 2 year
(Depending on the cruise line regulations)

When you join the Vessel all medical certificate should be not older than 30 days.

The General Information Form (Mod-5) must be filled out by you **digitally**. If you are not able to answer one or more questions, please contact us.

The personal form (Mod-5) must always be updated, if needed.

The **STCW-2010** must be recognized by **IMO**. Please send copies to OPS Ltd. as soon as possible.

Visas: it may depend on where the Vessel is sailing and from the country where you are coming from.

Seaman's book is required only in some cases. Please ask company were necessary.

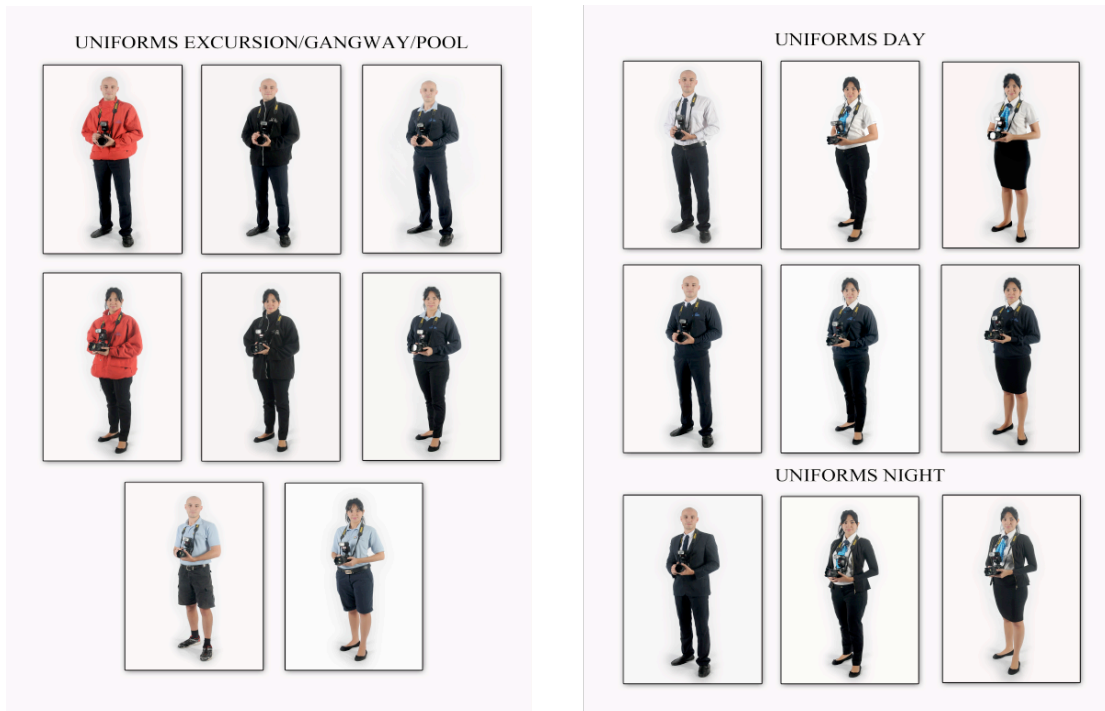
